**Who We Are:** *The National Public Lands Grazing Campaign* is a coalition of conservation organizations working end abusive public lands livestock grazing. The campaign has three components: (1) enforcement and accountability; (2) education and research; and (3) administrative and legislative reform. A steering committee, – comprised of representatives from American Lands, Center for Biological Diversity, Forest Guardians, Great Old Broads for Wilderness, Oregon Natural Desert Association and Western Watersheds Project — oversees the campaign. A primary goal is to enact voluntary federal grazing permit/lease buyout legislation that would allow grazing permittees/lessees to relinquish their permit or lease for generous compensation, while ending commerc livestock grazing on the associated federal grazing allotments. The campaign presently includes a staff of five.

The *Center for Biological Diversity* is devoted to protecting imperiled species, restoring degraded ecosystems, ar promoting progressive public policy. Based in Tucson, the Center works throughout western North America and I Pacific. Protecting public lands from destructive practices, especially livestock grazing, is one of the Center's primary goals.

**Job Description:** Organize public land grazing permittees/lessees, conservationists and other interested parties primarily in Arizona, to show support for enactment voluntary federal grazing permit/lease legislation in Congress. Work closely with all other NPLGC staff and CBD staff on livestock grazing issues, as well as with the NPLGC steering committee member organizations and others that have endorsed the legislation. The position focuses on legislative advocacy, as well as organizing support among various organizations and interests. Extensive travel, primarily in Arizona, but some to other parts of the West and Washington, DC, is required.

**Job Qualifications:** Lobbying experience, environmental activism, and/or relevant degrees are strongly desired, but none are a necessity. A strong antipathy toward public lands livestock grazing (if not innate or previously experienced, it can be learned in a day), coupled with a willingness to work in coalition with public lands livestock operators who favor our legislative agenda, is required. A professional style and appearance, desire to do good, ability to work well with others, and a capability to have fun are also required.

**Compensation:** \$25,000-40,000 annually, depending on experience, with generous vacation package and health insurance.
