RE: Senate Bill 1689


Gentlemen:

As leaders of organizations centrally focused and vitally interested in the well being of Doña Ana County, New Mexico and the Mexican border region, we have concluded in letters to you that Senate Bill 1689 should not be passed by Congress in the scope and the form that it now exists. We respectfully recognize the effort you have made in conceptualizing protective measures for the lands in question. Let it be recognized that this ad hoc body also supports permanent protection measures of the majority of these lands, and we differ only in the case of the Broad Canyon area where the future of Doña Ana County must be considered so carefully, and in the Potrillo Mountains complex, where permanent protection is supported, but national security requires a less restrictive designation for the protection of our county and our nation.

Although our individual duties and responsibilities may differ in various ways, our focus and our allegiance to the position of the Greater Las Cruces Chamber of Commerce set forth in a letter to you dated October 20, 2009 represents our united recommendation for the scope of your pending legislation. What must be made clear is that the community is not fully behind the legislation as currently written. We are obligated to seek your support for needed changes in the legislation by our 800-member coalition which includes 24 major organizations; our combined memberships in excess of 1500 businesses; our more than 8500 water constituents; our responsibilities mandated by New Mexico law; our responsibilities for flood and erosion control measures today and in the future; our community's future needs for energy, rail, and water supply corridors; our historical access to the most visited recreational destination in our county; our support for stewardship contracts through Restore New Mexico concepts; our country's need to actively counter the diminishing percentage of domestically produced food and fiber; our combined experience of over 9,000 man years of Border Patrol expertise, and our collective responsibility to keep our county and our country safe from border intrusions.

As set forth in the various letters sent by our collective leadership, we respectfully request that the Senate Energy and Natural Resources Committee schedule a field hearing in Doña Ana County, New Mexico so that all issues can be fairly presented in this matter that is so vital for our county, our border, and our national security.


