National Monument Hearing Comments 1-24-14 Las Cruces NM Jerry G. Schickedanz, Chairman Western Heritage Alliance

Thank you for coming to Las Cruces for a listening session on the issues of protection of public lands in Dona Ana County.

My name is Jerry Schickedanz and I am here speaking for the Western Heritage Alliance and the many other organizations and groups who were not afforded the opportunity to speak here today. The Western Heritage Alliance is composed of over 700 businesses in Dona Ana County who are opposed to a large scale national monument.

Madam Secretary, we support protecting the Organs Mountains and I think you will find a great deal of support here today for protecting just the Organ Mountains. There is large scale disagreement on protecting other lands in the county. We feel the Organ Mountains are fitting of a national monument.

For other lands that deserve some type of protection, then we recommend that they be protected under a simple withdrawal in the same manner that the Valle Vidal in northern New Mexico was protected in 2006.

Madam Secretary, I have letters from 16 groups representing a broad variety of organizations across Dona Ana County and the surrounding area in opposition to large national monument and would like to present them to you for your information and study.

These groups have concerns revolving around access for public safety, border security, watershed, flood control, economic viability, and continued livestock ranching.
